## Note:

- (1) The schedule should be prepared in the First Meeting of Board of Scrutineers and copy sent to the Honorary Secretary of the Centre and Headquarters.
- (2) Date of (f), (g) and (h) shall be confirmed / finalized by HQ in due course.
- (3) As per Regulation 6(a), the AGM of the Centre should be held on or before 31 October 2023. The notice of AGM which needs to be issued at least 15 (fifteen) days in advance may be issued without waiting for the results of election.
- (4) The invitation for nomination should also include the election time table mentioning important dates in the election process as fixed by the BOS in consultation with the IEI HQs.
